1. Call to Order and Roll Call
 - a. The April 17, 2018 Regular Monthly Board Meeting was called to order at 6: PM with, Chairman DeClark, Supervisor Neuens, Supervisor Payette, and Clerk Johnson present. Treasurer Ellison absent and excused
2. Approve / Amend agenda items

- a. MOTION (Neuens/Payette) to approve the agenda items for the April 17, 2018 board meeting. Motion carried. No negative votes.
- 3. Approve / Amend minutes of March 20, 2018 Regular Town meeting
 - a. MOTION (Neuens/Payette) to approve the March 20, 2018 regular Town Board meeting minutes as presented. Motion carried. No negative votes.
- 4. Treasurer's report
 - a. MOTION (Payette/Neuens) to approve the Treasurer's report as presented. Motion carried. No negative votes.
- 5. Public Comment;

- 6. Discussion on weight limit enforcement
 - a. It was made clear that the first step is to call the Marinette County Sheriff office with any information regarding trucks driving on Town roads when weight limit signs are up. The driver receives a citation. When heavy loads are put on a road during the spring thaw, it causes damage to the road. It is in the benefit of all town residents to contact the Sheriff when they see a truck breaking this law. The cost of repairing a road is shared by all Town residents.
 - b. Well, septic, and other emergencies are allowed to ask permission
- 7. Road Report
 - a. Couple culverts froze up
 - b. Great clean-up over the weekend with the heavy snow
 - c. Road inspection will need to wait until there is no snow.
- 8. Standing Committees
 - a. Planning Commission held a Public Hearing at 5:30 PM this evening (April 17, 2018) to discuss the changes to the Zoning map. The board will go through the list and recommendations and approve/deny the changes at the May 15th meeting. The Planning Commission approved the list provided on the agenda.
 - b. The Zoning Administrator report
 - i. The Zoning Administrator approved the building permit for Marchewka and Weyer
 - ii. Clean-up day collection on May 5th plus collection of electronics and items with freon will be available for pick-up or drop-off. People dumping garbage off roads will be monitored and prosecuted.
